Treasurer's Financial Statements for the Financial Year 2022-2023.

It gives me pleasure to submit this Treasurer's Report and Statement of Financial Position for the twelve months ended 30th September 2023.

Note: We prepare our accounts on a 'Cash' and <u>NOT</u> an 'Accrual' basis. Therefore, they do not consider any outstanding debtors or creditors as of the balance date. However, when prepared, there were no other abnormal costs/debt expected, from the normal operational income and expenditure.

Operational Income & Expenditure:

Income: Operating Income for the period was \$59,057 compared to \$38,598 for the previous

12 months.

Subscriptions Up by \$5,339 compared to the previous 12 months.

Expenditure Operational costs for the 12 months - \$22,020 compared to \$28,536 for the previous

12 months. The decrease is largely due to no Area Rep meeting during the year.

There are however some costs that may yet be claimed.

Surplus/Deficit The result for the year is a perceived operating surplus of \$28,913.

I say perceived as we there are funds received against events yet to happen. As mentioned previously, we do cash accounting, the simplest accounting required.

As mentioned at last year's AGM, we did a push on retention and many subscriptions came in after the close of the previous financial year.

Net Assets shown as of 30th September 2023 are \$88,468.
